## **INSTRUCTIONS TO THE CANDIDATE FOR PARTICIPATION IN THE SEAT SELECTION COUNSELING PROCESS**

### **Counseling Announcement**

Sri Devaraj Urs University is holding a Counseling through a single window for admissions to the Post-Graduate Medical courses for the academic year 2009-10 to ensure a merit based admission. For this purpose the University has already conducted entrance examination for the determination of merit.

The Rank List and the Rank Cards of SDUU-AIPGMET-2009 have been generated and dispatched already. General Merit Candidates (Karnataka/Non Karnataka), who have secured 50% and above in SDUU-AIPGMET-2009 are eligible for counseling. However, for candidates belonging to SC, ST, OBC (Karnataka/ Non Karnataka) 40% is the minimum marks in SDUU-AIPGMET-2009 for eligibility to participate in the counseling.

### **ORIGINAL CERTIFICATES TO BE FURNISHED COMPULSORILY AT THE TIME OF COUNSELING.**

1. SDUU AIPGMET-2009 Rank Card
2. SSLC or 10th Standard or equivalent Marks Card
3. MBBS (All Marks Cards)
4. Internship completion Certificate / Certificate for date of completion of internship in case of candidates who have not yet completed their internship at the time of Counseling.
5. Provisional / Permanent degree certificate.
6. State / Central Council registration / Provisional Certificate.
7. Certificate of recognition status of MBBS qualification by MCI issued by the Head of Institution.

8. Candidates belonging to Scheduled Cast (SC), Scheduled Tribe (ST) and Other Backward Class (OBC) are eligible to claim the lower eligibility (40%), provided they furnish a caste certificate issued by relevant authority not less than Tahasildar of the Taluk.

9. Demand Draft to be drawn in favour of '**The Registrar, SDUU, Kolar**' payable at Kolar for the annual tuition fee specified (Details refer to [www.sdumc.ac.in](http://www.sdumc.ac.in) / [www.sduu.ac.in](http://www.sduu.ac.in))

**NOTE:** Refund of excess amount if any in the Demand Draft submitted for annual fees for the course selected will be made, after adjusting the amount to be paid for the course selected/allotted subject to realization of the Demand draft submitted.

**THE FOLLOWING CERTIFICATES ARE REQUIRED TO BE FURNISHED AT THE COLLEGE LEVEL AT THE TIME OF ADMISSION:**

1. Eligibility certificate issued by The University (SDUU), for candidates who are not students of The University.
2. Transfer Certificate
3. Migration Certificate for candidates of Universities other than SDUU.

**1. Eligibility**

As per the Post Graduate Regulation 2000 of Medical Council of India, the minimum percentage of marks in the entrance test (SDUU-AIPGMET-2009) for eligibility for admission to Post Graduate Courses shall be 50% for general category candidates and 40% for the candidates belonging to Scheduled Castes, Scheduled Tribes and Other Backward Classes.

**Note: Only those candidates who have completed / expected to complete their Internship on or before 30/4/2009 are eligible for seat selection.**

### **3. TUITION FEE**

The Annual tuition fee amount for the first year, for different courses should be paid by the candidates when they come for Counseling, in the form of a **Demand Draft (DD) drawn in favour of The Registrar, SDUU, Kolar, payable at Kolar.** The candidates should come prepared with the Demand Draft before registering themselves for selecting a seat, failing which they will not be allowed to participate/enter the counseling hall. **Cash or cheque, shall not be accepted for any reason.**

Note : Tuition fee is payable per year on or before 15<sup>th</sup> May each year for remaining part of the course. Failure to pay entails suspension from the course of study.

### **4. PROCEDURE OF SEAT SELECTION BY THE CANDIDATES**

Selection of a seat by a candidate at Sri Devaraj Urs University and admission thereafter at the Sri Devaraj Urs Medical College, Kolar.

Counseling shall comprise the following stages:

- Verification of the Original documents & Demand Draft.
- Registration of the candidates
- Exercising the option by candidates which involves selection of seats in accordance with order of merit.
- Remittance of Fees in the form of Demand Draft
- Issue of Allotment letter.

All the eligible candidates will be informed individually about the counseling date and time well in advance.

The counseling date is fixed on 23.03.2009.

On the day (23.03.2009) of counseling the registration of the eligible candidate will take place between 9.00 AM to 1.00 PM.

All eligible candidates should get themselves registered within this time period.

Before registration each candidate should get all certificates verified at the verification counter and obtain verification form duly signed by the signatories.

No candidate shall be permitted to get registered after 1.00PM on 23.03.2009.

The registration is mandatory failing to attend the registration process will disqualify candidate from seat selection/counseling process.

The seat selection process will commence from 2.00PM onwards on 23.03.2009.

The candidates in the order of merit as per the rank list published by the university will be called for seat selection as per the schedule mentioned.

They shall then follow instructions as per the details provided in the counseling announcement as mentioned below.

Candidates are advised to bring a complete set of Xerox copies of original certificates asked by the University.

**Seat selection:** The candidates will be allowed to select a Subject of study of their choice strictly in the order of merit. The candidate will be allowed to participate for seat selection in accordance with the notified time schedule and as per the order of Merit. After verification the SDUU will retain only the set of photocopies and the original set of documents will be returned to the candidates for submitting the same to Sri Devaraj Urs Medical College at the time of admission.

Besides, documents like:

- (i) Eligibility certificate issued by The University (SDUU), for candidates who are not student of The University.
- (ii) Transfer Certificate.
- (iii) Migration Certificate for candidates of Universities other than SDUU.

as applicable, will have to be submitted directly at the time of admission to the college.

Biometric verification, photo verification and signature verification will be made and therefore the **candidate is required to be present compulsorily for seat selection process. Only one person (parent, guardian or spouse) can accompany the candidate for the entire counseling process.**

The entire seat selection process in the SDUU is controlled by a computer system right from the stage of registration till the stage of printing of Allotment letter. The highly sophisticated software used in the system has the ability to control the initial registration, provide data for verification of the original documents and to take care of the selection of the seats by the candidates in the order of merit, payment of fees and finally printing of Allotment letter. We assure you that, once the candidate comes to the seat selection by registering and verifying the documents, order of merit cannot be changed as it is computerized. A candidate who has the better rank gets the opportunity to select a seat, a candidate who has the rank next to him cannot think of bypassing him. He will have to wait for his turn at the seat selection terminals. A dynamic screen will show course-wise availability of seats, which helps the candidates to make up their mind in advance. The moment a seat is selected by the candidate, the computer will show one seat less against the course from which the candidate has selected the seat. The candidate will be given a letter of offer for the particular course along with the details of payment to be made by the candidate. The candidate has to deposit the Demand Draft at the counter provided in the counseling hall. After this the candidate will be given the Allotment letter that he/she has to submit at the college at the time of admission.

**No candidate will be allowed to change the seat once selected during this round. Candidates are cautioned here that they have to be very careful during this process, as the computerized system cannot be reversed**

especially if the rank below him has already exercised his choice of seat selection. After the candidate is allotted a seat. He/she should get admitted to the college (SDUMC) on or before the date and time mentioned in the allotment letter otherwise the seat allotted will be forfeited.

#### **Grounds for Rejection:**

- If on verification the documents of the candidates is not found to be in order or if there is any on falsification of documents or if the expert committee is not convinced about the documents submitted at the verification counter his/her candidature will be rejected.
- If there is a mismatch of photo, finger impression signature of the candidate or if there is a reasonable doubt by the expert committee that there is malicious intent of the candidate to impersonate such candidate/s will be debarred and criminal proceedings may be initiated.
- If the candidate does not get the prescribed amount in form of Demand Draft their candidature will be rejected.
- Candidate must be physically present and no proxy registration will be accepted.

#### **5. REFUND**

Those Candidates who have been allotted seats and have not taken admission in the constituent college shall be given refund of fee after deduction of 5% (Five percent) from the total fee paid. This shall be applicable to only those candidates who surrender their seats and submit a written request for refund well in advance within the specified time and date mentioned in the allotment letter to get admitted in the constituent college.

#### **6. LEGAL JURISDICTION**

Any dispute that may arise in respect of the seat selection process and admission is subject to the jurisdiction of the Hon'ble High Court of Karnataka and consumer court of Bangalore. **The issue of Allotment letter by the SDUU is provisional which is to enable the candidate to join Sri Devaraj Urs Medical College, Kolar subject to his meeting all the eligibility requirements as prescribed by MCI as well as SDUU, Kolar, Karnataka.** Hence at the college level all the original documents are once again verified before acceptance, besides biometric, photo and signature verifications.

#### **7. ASSISTANCE**

Candidates seeking any clarification or assistance for specific problems with regard to the seat selection process are required to contact SDUU Office well in advance for redressal. SDUU suggest all the candidates to visit the website regularly for the latest updates.

### **Seat Selection :**

The Registered candidates will be called for seat selection and allotment in the order of merit from 2.00 PM onwards on 23.03.2009. If the candidate is not present when called in the order of merit, he/she shall forfeit the right to select any seat and will be disqualified from the seat selection process.

The candidates who have selected seats in the first round of counseling shall get themselves admitted in the Sri Devaraj Urs Medical College on or before 31<sup>st</sup> March 2009, 5.00 PM failing which the seat allotted will be forfeited.

## **SECOND ROUND OF COUNSELLING**

The Second round counseling will be held on 2<sup>nd</sup> April 2009 to fill up the vacant seats available if any. **Candidates who have registered for the first round of counseling only shall be considered for the 2<sup>nd</sup> round of counseling.** The candidates who have selected seats in the second counseling shall get admitted themselves in the Sri Devaraj Urs Medical College on or before 9<sup>th</sup> April 2009, 5.00 PM failing which the seat allotted will be forfeited.

**Failure to get admitted in the college will result in forfeiture of the seat.**
