1. INTRODUCTION

All India Post Graduate Medical Entrance Test 2011 (AIPGMET 2011) will be conducted for admission to various Post Graduate Courses conducted at Dr. D.Y. Patil Medical College, Nerul, Navi Mumbai 400706, a constituent college of Padmashree Dr. D.Y. Patil University on 24th January 2011 from 10.00 AM to 1.30 PM

The college was established in 1989 and is recognized by the Medical Council of India, New Delhi . The college is associated with a 1150 bed teaching hospital in its campus having state of the art facilities for healthcare and treatment

The Admission committee of the University will be responsible for conduct of the entrance test , declaration of results, counseling and final admission to the courses.

2.2 Approval of some courses/ increase in intake from Government of India & Medical Council of India is expected. Admission to these courses will also be based on the performance of the candidates at the AIPGMET 2011.

2.3 a. General Category : 50 % Seats are in this category . Admission to this category will be made on the basis of inter-se-merit of the candidates at AIPGMET 2011

b. NRI Seats : 50 % of the seats are reserved for NRI quota . Admission to this category will be also on the basis of inter-se-merit of the candidates at AIPGMET 2011. The candidate desirous of getting admission under this category will have to apply separately on a prescribed form made available on the web site.

MODE OF ENTRANCE TEST

3.1 The AIPGMET 2011 will be of three and Half hours duration containing 300 multiple choice questions (MCQs). Questions will be single best response objective type with four answer options. Each correct answer will be awarded one mark. There shall be no negative marking for incorrect answers.

3.2 The examinations will be conducted in English

3.3 The entrance Test shall be of the standard of M.B.B.S. examinations and shall cover all the subjects of the M.B.B.S. course. The subject wise distribution of MCQs will be as follows

3.4 There is no provision for revaluation of answer books.

4. ELIGIBILITY

- 4.1 The candidate must be an Indian National. Nationality Certificate issued by District Magistrate or Additional District Magistrate or Chief Metropolitan Magistrate Valid Passport shall constitute proof of nationality.
- 4.2 The candidate must have passed M.B.B.S Examinations from recognized Medical College and should have obtained final registration either from the Medical Council of India, New Delhi or Maharashtra state Medical Council after completion of one year rotating internship training.
- 4.3 The candidate undergoing one year rotating internship training and likely to obtain final registration certificate from Medical Council of India, New Delhi or Maharashtra on or before 15th April 2011 can also appear for the entrance test. Such candidates will be required to submit a certificate from the Principal / Dean of the college regarding the likely date of completion of their rotating internship training, failing which their application will be treated as incomplete and shall be rejected.

5. RAGGING

It must be noted that the Institute consider ragging a cognizable offence and will not hesitate to take strong action against the offenders .

Here are extract from the UGC's Committee Report.

Guidelines given by the University Grants Commission to curb the Menace of Ragging in Universities / Educational Institutions.

The word RAGGING means the act of teasing ,taunting, playing a practical joke upon someone or holding comic parade and other activities during certain period of a college term to raise money for charity.

Forms of Ragging

Ragging is found to take the following forms (the list is only indicatives and not exhaustive).

Crisp Orders

- To address seniors as 'Sir';
- To perform mass drill;
- To copy class notes for the seniors;
- To server various errands;
- To do menial jobs for the same;
- To ask / answer vulgar questions;
- To look at pornographic pictures to shock; the fresher out of their innocence;
- To force to drink alcohol, scalding tea , etc;
- To force to do act with sexual overtones , including homosexual acts;
- To force to do acts which can lead to physical injury / mental torture or death;
- To strip, Kiss ,etc;
- To do other obscenities;

Punishments

The following could be the possible punishments for those who are found guilty of participation in or abetment of ragging. The quantum of punishment shall naturally , depend upon the nature and gravity of the offence as established by the Disciplinary Committee or Court of Law.

1. Cancellation of admission.
2. Suspension from attending classes.
3. Withholding / withdrawing scholarship / fellow ship and other benefits.
4. Debarring from appearing in any test / examination or other evaluation process.
5. Withholding results.
6. Debarring from representing the institution in any national or international meet , tournament, youth festival etc.
7. Expulsion from Hostel.
8. Rustication from Institution for period varying from 1to 2 semesters.
9. Expulsion from Institution and consequent debarring from admission to any other institution.
10. Fine up to Rs.25,000/-.
11. Rigorous imprisonment up to three years.

While the first 10 types of punishments can be awarded by the appropriate authority of the institution itself, the last punishment can be awarded only by court of law. Students / Parents should sign declaration from at the time of counseling given in **Annexure I and Annexure II.**

6. CENTERS FOR ENTRANCE TEST

The Entrance test will be conducted at The Campus of the University situated in Sector 7, Nerul , Navi Mumbai. Maharashtra India .

The name of the college assigned to the candidates and their hall ticket numbers shall be notified on the website of University i.e. www.dypatil.ac.in

7. APPLICATION FORM

7.1 On Line Application Form from website

The candidates desirous of appearing for All India Post Graduate Medical Entrance Test 2011 of this University will be requiring to fill up the application form on line. The form is available on the University web site www.dypatil.ac.in under section PG Entrance Test Section.

The candidate must read the instructions for filling up the on line application form. These instructions are available on the web site

Transaction ID is number allotted to applicant by the On Line Application registration system after submission of the On line application successfully. The system also automatically emails the candidate the transaction id allotted.

7.2 Entrance Test Fees

The entrance Test fees is Rs.2000/-. The fees is payable by Demand Draft drawn in favour of Padmashree Dr. D.Y. Patil University drawn on a nationalized or scheduled bank, payable at Navi Mumbai / Mumbai.

The candidate should write HIS/HER name and address and Transaction ID number on the reverse side of the demand draft

Candidate can pay the entrance test fees via Demand Draft OR Credit Card , Debit Card , Internet Payment , cash card or Mobile payment options

7.3 The Last Date of registration of applications forms is 15th January 2011 up to 5.00 PM IST

The forms will be accepted up to 20th January 2011 along with Late Fees of Rs.500/- The candidates submitting applications after 15th January need to pay registration charges of Rs.2500/- by Demand Draft drawn in favour of Padmashree Dr. D.Y. Patil University drawn on a nationalized or scheduled bank, payable at Navi Mumbai / Mumbai.

Your demand draft MUST be accompanied by necessary attested copies of documents (Refer Section No 13) and it should be addressed

8. Hall Ticket

The Hall ticket carrying photograph shall be emailed to email address mentioned in the on line application form filed up by the candidates.

The Hall Ticket will be emailed only after the receipt of registration fees and required necessary documents. (**Refer Section No 13**)

Candidate can download hall ticket from University website i.e. www.dypatil.ac.in by entering date of birth and Transaction ID number.

Please note that hall ticket will not be dispatched to the candidates.

The hall ticket must be presented in the examination hall for verification of candidate's identity when instructed by the invigilator to do so and also at the time of counseling. The Hall Ticket is not transferable.

9. Selection Procedure

9.1 The selection of candidates will be done on the basis of inter-se-merit of candidates taking in to consideration the preference given by the candidates and availability of seat in the branch / discipline of the his /her choice when called for counseling .

9.2 Tie Breaker

In case of equal marks at AIPGMET 2011 inter-se-merit of candidates will be determined by applying following tiebreaker rules :

A] First Level : A candidate securing higher percentage of marks in the aggregate of marks at the first. Second and Third M.B.B.S (Part I and Part II) examination taken together ,will be preferred. If the tie still persist then :

B] Second Level : A candidate securing Higher percentage of marks in the Third M.B.B.S (Part I and Part II), will be preferred. If the tie still persist then :

C] Third Level : A candidate securing higher percentage of marks at the second M.B.B.S Examinations, will be preferred If the tie still persist then :

D] Fourth Level : An older candidate will be preferred over younger candidate.

10 Fee Structure

Exam fees will be notified from time to time

10.2 The tuition fee for the first year will have to be paid within time limit given at the time of counseling . Failure to pay the tuition fees within specified time will result in automatic cancellation of admission offered to candidate.

10.3 The tuition fees for the subsequent years will have to be paid as and when notified by the University / College. The candidate may be required to give a bank guarantee to cover fees of subsequent years.

10.4 The fees once paid are non refundable.

11 Declaration of Result

Date of Result and Counseling schedule will notified on the University website. Candidates should visit website for result updates.

12. Counseling

12.1 At the counseling the eligibility of the candidate for admission shall be verified from the original documents and those found eligible will be offered admission to courses.

12.2 The candidates will have to appear for counseling at their own cost

12.3 The physical presence of candidate at the counseling is essential. Absence of candidate at the specified time, date and venue will result in instantaneous forfeiture of any claim for admission and University will not be responsible for it.

12.4 Asking a candidate to report for counseling does not mean that He/ She will be admitted to the course. The actual admission will be depend upon the course and seats availability when his / her turn comes in order of his / her inter-se- merit position

15. GUIDELINES FOR ENTRANCE TEST

15.1 Candidates must be present at the examination hall and occupy the seats allotted to him/her half an hour before the commencement of entrance test.

15.2 15 Minutes prior to commencement of examinations , the invigilator will give general instructions regarding entrance test.

15.3 During the test the invigilator will check the identity of the candidates by the referring hall ticket given to him /her

15.4 The candidate must sign on the Attendance Sheet

15.5 The answer sheet will be given to candidates at 1111 pm and test booklet will be given at 1111 pm. The candidates shall read instructions printed on both Test Booklet and Answer sheet and make correct entries. The correctness of entries will be cross checked by invigilator

15.6 For answering the questions , the candidate shall darken the appropriate circle using blue or black ball point Pen

15.7 Each correct answers will be rewarded one mark. However if more than one circle darken or any other marking method is used , no marks will be awarded.

15.8 Rough work , if any should be done in the space provided in the test booklet. Rough work should not be done anywhere on the answer -sheet

15.9 Printed log tables containing Log , Anti log ,Sin ,Cos, Tan and Square Roots only are permitted , Log tables with formulae , conversion tables , calculators, cellular phones and any other electronic gadget are not allowed in the Examination hall

15.10 Smoking is strictly prohibited in University campus and Examination hall

15.11 No candidates will be allowed to leave the examination hall till the entrance test is over

15.12 After the entrance test is over the candidates must hand over the Test Booklet and Answer sheet to invigilator

16 DISCIPLINE

The candidate admitted for the courses in the constituent college of University are subject to the discipline and conduct Rules of University. The discipline committee of University will deal with all cases involving discipline or conduct either suo moto or when referred to it by the Principal / Dean of the college. The decision of Vice chancellor shall be final in this regards

17. COURT JURISDICTION

Any legal dispute arising out of conduct of All India Post Graduate Dental Entrance Test 2011 (AIPGMET 2011) And admission procedure shall be subject to the jurisdiction of the court of Navi Mumbai and High Court of Mumbai only.

- Candidates should not speak or communicate in any manner to any other candidate, while the examination is in progress. If a candidate wants anything, he/she should approach the invigilator without disturbing other candidates however, he/she should not leave the seat on any account.
